

# CHILDREN'S DAY CAMP July 12-16, 2010 INFORMATION SHEET

Please read all information carefully before registering your child!

## CAMP TUITION

"Early Bird" Discount: Postmarked by May 15 = \$103.00  
Late Registration: Postmarked after May 15 = \$135.00  
(These amounts include a Non-refundable Deposit of \$30.00)

**Deposit to reserve a space:** A \$30.00 non-refundable deposit will reserve a place for your child. This is included in the above tuition amounts. The \$30.00 deposit is non-refundable.

**Cancellations and Refunds:** Cancellations prior to May 29 will receive a full refund less the non-refundable deposit fee of \$30.00. Cancellations after May 29 will receive a full refund less the non-refundable deposit fee of \$30.00 and an additional \$25.00 processing fee. No refund will be made after July 1 unless a written physician's excuse is provided.

**Check Returns:** A \$30.00 service charge will be assessed for any check returned by the bank.

**Health History Form:** A new Health History Form is required each year. Registration for camp is not complete until this form is received. **A photocopy of the front and back of your health insurance card must accompany the health form.**

**Medications:** All medications needed during day camp hours must be placed in a clear ziplock bag with the child's name printed on the outside. Instructions for administering medications must be placed inside the bag. This bag will be provided to the camp director upon arrival each day at camp. No medication will be administered without adherence to these instructions.

**Location/Transportation/Supervision:** Day Camp will be held at Camp Carolwood, located off Hwy. 321N near Lenoir. Each individual or church sending campers is responsible for their transportation to and from camp. Arrival is between 8:45-9:00 a.m., with departure promptly at 4 p.m. If a camper plans to leave with anyone other than the person who brought them, the camp director must be notified in advance. Churches are encouraged to follow "Safe Sanctuary" procedures when transporting children. Each church sending campers is required to have at least one adult (18 years or older) to remain on site to assist each day.

**Responsibility:** Campers are expected to be polite and cooperative with other campers and staff. Rules will be established to promote a fun and safe environment. Do not bring radios, video games, ipods or cell phones unless they are left in the car, bus or van. (There is no cell phone coverage at Camp Carolwood.) Emergency phone calls may be placed to the Camp phone: **(828) 758-1467.**

**Insurance:** Camp Carolwood provides excellent secondary accident insurance (illness not covered). Your family health care policy is the primary provider.

**Camp is open to all:** Day Camp is open to all children regardless of gender or national origin. It is a Christian camp with songs, games, and Bible studies, which emphasize age appropriate Christian values. Any Christian denomination is welcomed.

**Safe Sanctuaries Policy:** The United Methodist Church policy of "Safe Sanctuaries" will be followed to keep children and adults safe.
